PRE-EMPLOYMENT SCREENING PROGRAM (PSP) ARE YOU HIRING THE SAFEST DRIVERS?

The Federal Motor Carrier Safety Administration (FMCSA) launched the Pre-Employment Screening Program (PSP) in 2010 to help motor carriers review drivers' crash and inspection records. Make use of this tool when considering your next hire. Want to know why?

PSP OFFERS VALUABLE DATA.

Review a drivers' 5-year crash history and 3-year roadside inspection history as part of pre-employment screening and avoid these red flags:

- Phone use or texting while driving
- Driver at-fault crashes
- Speeding
- Logbook violations
- Job hopping

Reduce the risk of hiring an unsafe driver by joining the thousands of motor carriers already using PSP!

DOES PSP REALLY HELP MAKE ROADS SAFER?

A safety study was conducted to evaluate PSP's effectiveness. Results showed that carriers using PSP helped:

- lower crash rates by 8%, on average
- lower driver out-of-service rates by 17%, on average

HOW PSP HELPS YOU HIRE SAFE DRIVERS:



PSP HELPS IDENTIFY UNSAFE DRIVERS

After a fatal accident in Tennessee involving a commercial vehicle, the National Transportation Safety Board (NTSB) conducted an investigation. Their findings showed that the motor carrier company involved in the incident did not use PSP when evaluating their driver for a position. NTSB noted that **had the company used PSP, they may have determined that the driver was not suitable for a safety sensitive position** based on the information listed on his PSP report.



PSP HELPS IDENTIFY PATTERNS IN DRIVER HISTORY

The PSP report is different than an MVR because it is a record of an occurrence versus a conviction record. **When requesting a PSP report, carriers can identify patterns based on the violations listed on a PSP report.** Identifying these patterns will help determine whether this driver is a good fit for your company.



PSP HELPS IDENTIFY INACCURATE DRIVER HISTORIES

PSP has helped carriers identify drivers who are not forthcoming on their driver applications. When a company requests a PSP record, they are able to view the carrier the driver was working for when he/she received a violation. If that carrier was never listed on their driver application, it could indicate a bit more investigation is necessary.



USING PSP HELPS PROTECT AGAINST NEGLIGENT HIRING LITIGATION

Many in the industry have mentioned that PSP can be an asset to them when involved in negligent hiring litigation.
