## 2024 Inspection Blitz: Focus Areas Tip Sheet



This year's International Roadcheck will focus on tractor protection systems and controlled substance and alcohol possession.

#### Tractor Protection and Anti-Bleed Back Systems

A commercial motor vehicle's tractor protection system consists of a tractor protection valve, trailer supply valve and anti-bleed back valve. All valves should be properly tested during a inspector's roadside inspection and an inspector's roadside inspection.



During the inspection of tractor protection system components, the inspector will:

- Ensure the wheel chocks are still in place and have the driver release all the brakes by pressing dash valves.
- Have the driver carefully remove the gladhands and allow air to escape
- Ensure the air stops leaking from the supply line with at least

#### Controlled Substance and Alcohol Possession

Controlled substance and alcohol possession by commercial motor vehicle drivers is a significant concern. In addition, the number of prohibited drivers in the U.S. Drug and Alcohol Clearinghouse (DACH) is increasing. This alarming trend poses a threat to all motorists on our roadways.

While checking for the presence of alcohol or controlled substances during an inspection, inspectors will:

- Observe the driver for signs of alcohol or controlled substance use and/or impairment.
- Examine the cab and trailer for alcohol or controlled substances.
- Conduct a query in the DACH (for inspections in the U.S.).



## #1 Inspection, Repair, and Maintenance (396.3)

#### **Examples:**

- Brake Defects
- Electrical Systems
- Coupling Devices
- Driveshafts
- Fuel leaks
- Steering Components



## #2 Inoperable Required Lamps (393.9)

#### **Examples:**

- Front: Headlamps, high beams, turn signals, running lamps, clearance lamps, identification lamps
- Rear: Stop lamps, tail lamps, turn signals, clearance lamps, identification lamps, license plate lamp
- Sides: Intermediate lamps, front and rear side markers



#### Solutions:

- Pre-trips
- Brake Buddy
- System check



## #3 Local Law Violations (392.2)

#### Examples:

- Speeding
- Improper lane usage
- Fail to obey traffic control device
- Improper lane change
- Failure to stop at weigh station
- Following distance
- Distracted driving



## #4 Oil and Grease Leaks (396.5)

#### **Examples:**

- Dripping or forming drops during inspection
- Oil pan, power steering, wheel ends, transmission, engine, etc.

#### **Solutions:**

- Clean up old leaks
- Pre-trip
- DataQ



# #5 Improper Markings (390.21)

- Both side must display carrier name and "USDOT" number
  - Visible from 50 feet
  - Contrasting color
  - Durable and maintained
- Lease agreement required if less than 30 days
- Interline agreements
- Must display "operated by" if more than one name is displayed

#### **Solutions:**

Pre-trip and document inspection



# #6 Emergency Equipment (393.95)

### Fire Extinguishers

- Must be mounted securely and accessible
- Must have gauge and be charged
- Minimum size 5 B:C or two 4 B;C

#### Warning Devices

- Requires three warning triangles or six fuses
- Must be operational and accessible
- Must be placed within ten minutes
- Placed at 10 feet, 100 feet and 200 feet (40 paces)

#### **Spare Fuses**

Only required if required components use fuses
